Dear MSWCA Vendor,

Join us in Memphis for the 2019 Mid-South Workers' Compensation Association Conference **October 10-11**. We are very excited to be presenting our **STATEWIDE** event which will be held at The Great Hall (1900 S. Germantown Road, Germantown, TN 38138)!

The theme this year is "Welcome to Memphis." We encourage any decoration of your booth to reflect the MEMPHIS Spirit. There are many Memphis themes including, but not limited to Beale Street, The Peabody, ELVIS, Graceland, Memphis BBQ, Memphis in May, Stax Museum, FedEx Forum, The Liberty Bowl, Memphis Redbirds, Memphis Grizzlies, Memphis Tigers, 901 Memphis FC, The Orpheum, Gibson's Donuts, Memphis Zoo, and the list goes on! We challenge you to have fun and be creative as it draws people to your booth and gives you an opportunity to promote your company. This event is well attended by all who have a hand in workers' compensation. We will have Adjusters, Employers, Nurse Case Managers, Human Resource Directors, Safety Engineers, Occupational Health Nurses, Attorneys, and Medical Providers attend this conference.

***NEW THIS YEAR — Each vendor will have full control of creating a Memphis themed centerpiece for one round table where attendees will sit during the conference (this centerpiece will NOT be at your booth during the conference). In the spirit of competition, we will let all attendees vote on the centerpiece decoration and the WINNING vendor will receive \$350 CASH. Rules for decorating: Centerpiece CANNOT be taller than 15", no lit candles, no balloons, no tape(of any kind), no glitter, no confetti, no birdseed, no flower petals, etc., Table comes with white table cloth, but you can bring a different color if you so wish to go along with your decorations.

This year's Vendor Booth registration is \$650 for EARLY BIRDS which means Registration AND Payment MUST BE RECEIVED on or prior to August 31st. NO EXCEPTIONS. Any registration and/or payment received AFTER July 31st – the fee will increase to \$700. Each Vendor Fee includes two (2) complimentary conference registrations. All vendor booths include a 6' table, 2 chairs, and a WHITE tablecloth. If your company would like to include more than 2 team members, there will be an additional charge for each attendee. If payment is received on or before July 31st each additional attendee will be \$175 and after July 31st the fee is \$200. PLEASE NOTE: Vendor Booth selection will happen in the order Registration AND Payment are received and will start mid-September. Both Registration AND Payment must be received before your company will be able to select your Vendor Booth location in the venue.

All Vendors must be registered AND PAID no later than September 6, 2019. Included in the Vendor Fee is the booth space, two (2) complimentary conference registrations, and a full-page black and white ad highlighting your company in our booklet which is given to all attendees at check-in. All full-page ads will need to be submitted to Isray@selectmedical.com no later than August 30, 2019 to be included in the booklet. If you do not have an ad, one can be created on your behalf.
